Through the pursuit of choral excellence, I am learning to value and experience the joy of singing while developing essential life skills such as self-confidence, discipline, cultural awareness, responsibility, and a commitment to community service.

Allegro began in 2000 with one choir and 38 singers and has grown to three auditioned choirs with over 150 voices representing 62 different schools from the entire Kansas City metro area. Allegro offers a comprehensive music education program for singers in grades 3-12 and provides unforgettable musical experiences for both participants and audience members.

Allegro directly impacts our community by providing beautiful concerts each season as well as at least one benefit concert for a local children's charity. In the past, Allegro has held benefit concerts to raise funds for Harvester's Food bank, for the construction of a home for a Sri Lankan family after the tsunami, and for the New Orleans's Children's Chorus in the aftermath of hurricane Katrina. More recently, Allegro's 2006 benefit concert raised over \$2,000 for Children's Mercy Hospital and another \$1,000 for the Kansas City Community Kitchen.
